## Enclosures

Items to be submitted along with the entry form.

Photo copies can be sent and originals to be submitted for verification during pre-event scrutiny

- ❖ Entry Form : Complete all details in block letters. The entry form is incomplete if the 'Declaration' is not filled out
- ❖ Entry Fee : The prescribed fees, should be paid by pay order, draft, postal order, etc. by crossed account payee cheque.
- ❖ Photographs : Passport sized photographs (2 nos) for driver is required to be submitted with the entry form with the name written on the reverse side
- ❖ Indemnity & Declaration Letter : It is a part of the entry form given with the supplementary regulations and has to be filled in and signed
- ❖ Letter of Authority : Letter of authority from the registered owner of the vehicle (if other than the entrant) permitting use of the vehicle in this event.
- ❖ Registration Book : The registration book of the vehicle with proof of current tax paid has to be produced during the pre event scrutiny. A photocopy of the same must be submitted with the entry form.
- ❖ Driving License of competitors : The Driver must possess a valid driving licence. A photocopy is to be submitted. The Driver must carry the original license during the rally.
- ❖ Where ever photocopies are submitted, originals must be produced for verification on or before pre-event scrutiny.

*This checklist is a guide to help competitors complete their documentation process, with minimum trouble. Additions (if any), in the above listed requirements shall be posted on the event notice board.*
