2011: Terms & Conditions for 2W

- 1. Please write in CAPITAL letters only.
- 2. Attach **2 stamp size photographs** for EACH DISCIPLINE applied for eg.. 4 photographs would be needed if you apply for both rally and racing license.
- 3. If you are 18 years or above, Xerox copy of your Civil Driving License (NO ORIGINALS PLEASE) self attested (signed), is mandatory for all Discipline.
- 4. For Rallying / Raid or public road events, license is issued only to riders having Civil Driving License.
- 5. For Road Racing / Drag, the minimum age is 13 years for Group D upto 130 cc and Moped Class only. For all other classes, the minimum age is 15 years. The minimum age starts on the date of the rider's birthday.
- 6. Applications from under 18 years applicants must be endorsed by a recognized team / FMSCI Member Club for issue of license.
- 7. For all applicants below 18 years of age, Proof of Age (Xerox of Birth Certificate, Passport etc) is mandatory.
- 8. Applicants who attain 50 years in the year of application are not eligible.
- 9. One event licenses are valid only for Closed Invitation & Open events. The Medical Forms (Appendix "A" & "B") is not required. Indemnity form is a MUST.
- 10. Restricted License holders are allowed to participate in Group D (unmodified) only.
- 11. Full Competition License is a MUST for Group C,B & A
- 12. Seeded riders will be issued only Full Competition Licenses
- 13. Full competition license is issued only to those who have participated in atleast 3 events for the discipline of license applied for. Proof of the same is to be submitted by applicant.
- 14. Demand draft in favour of "The Federation of Motor Sports Clubs of India", payable at Chennai towards license fees. All licenses are valid till 31st Dec of each year.
