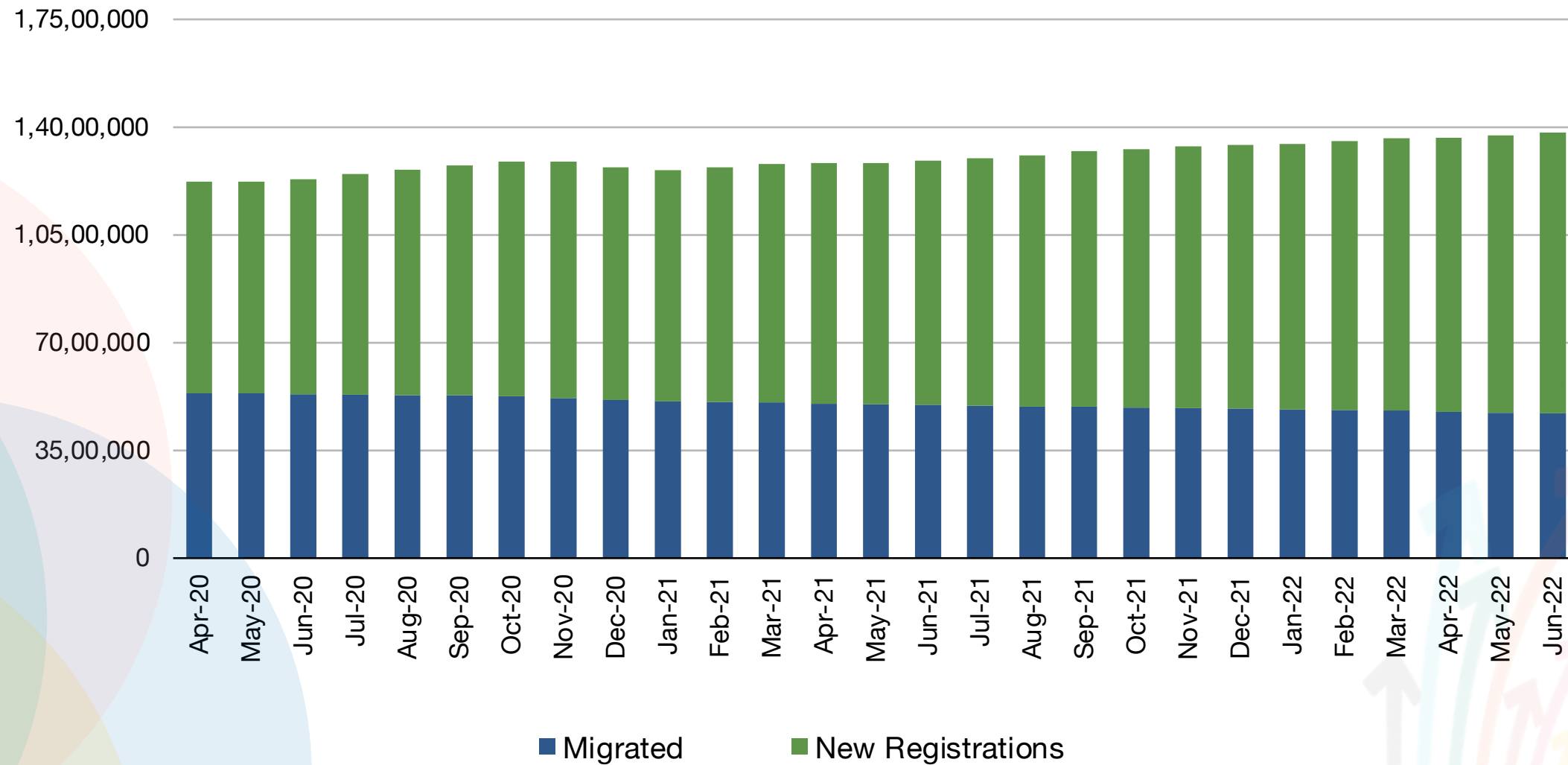

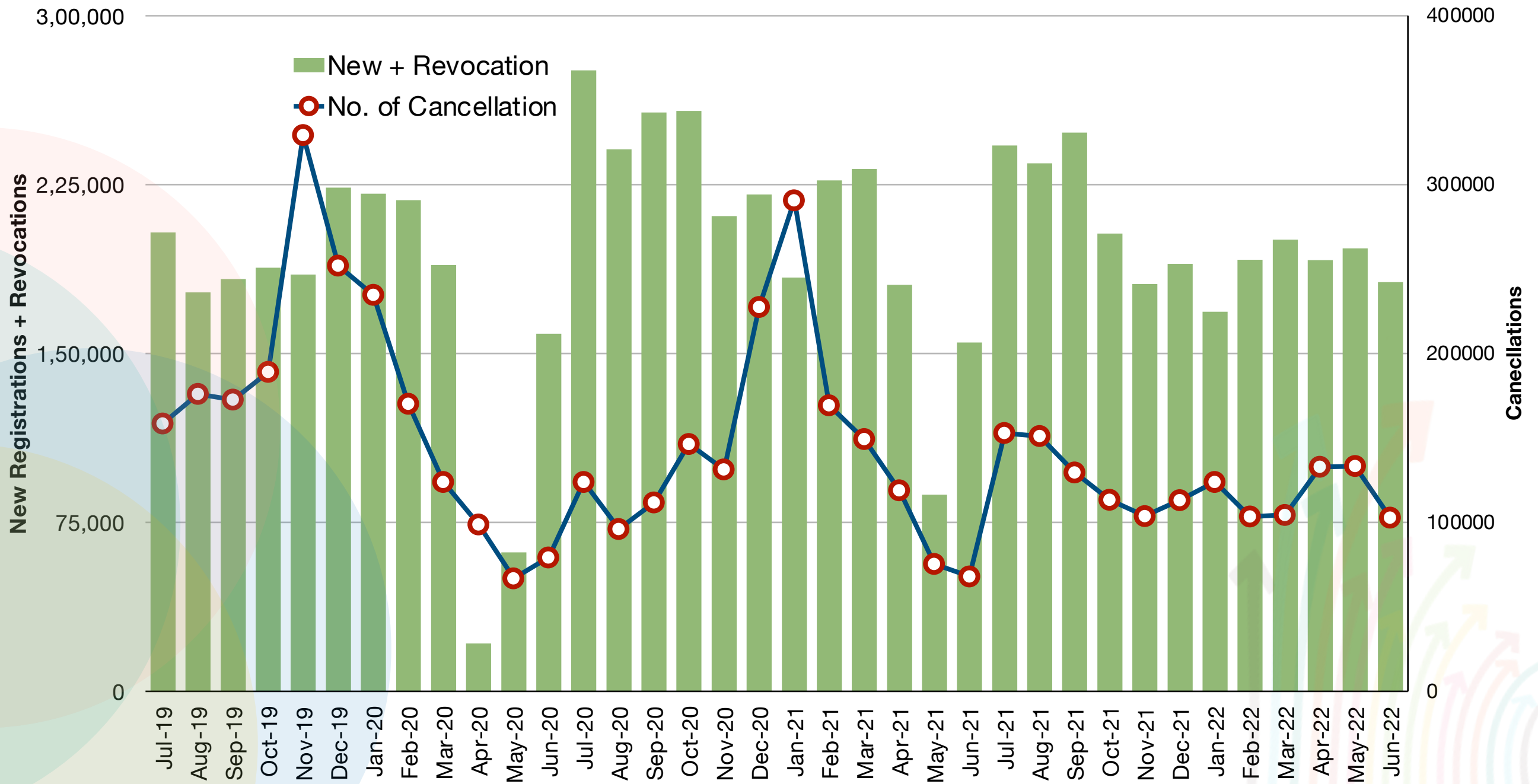

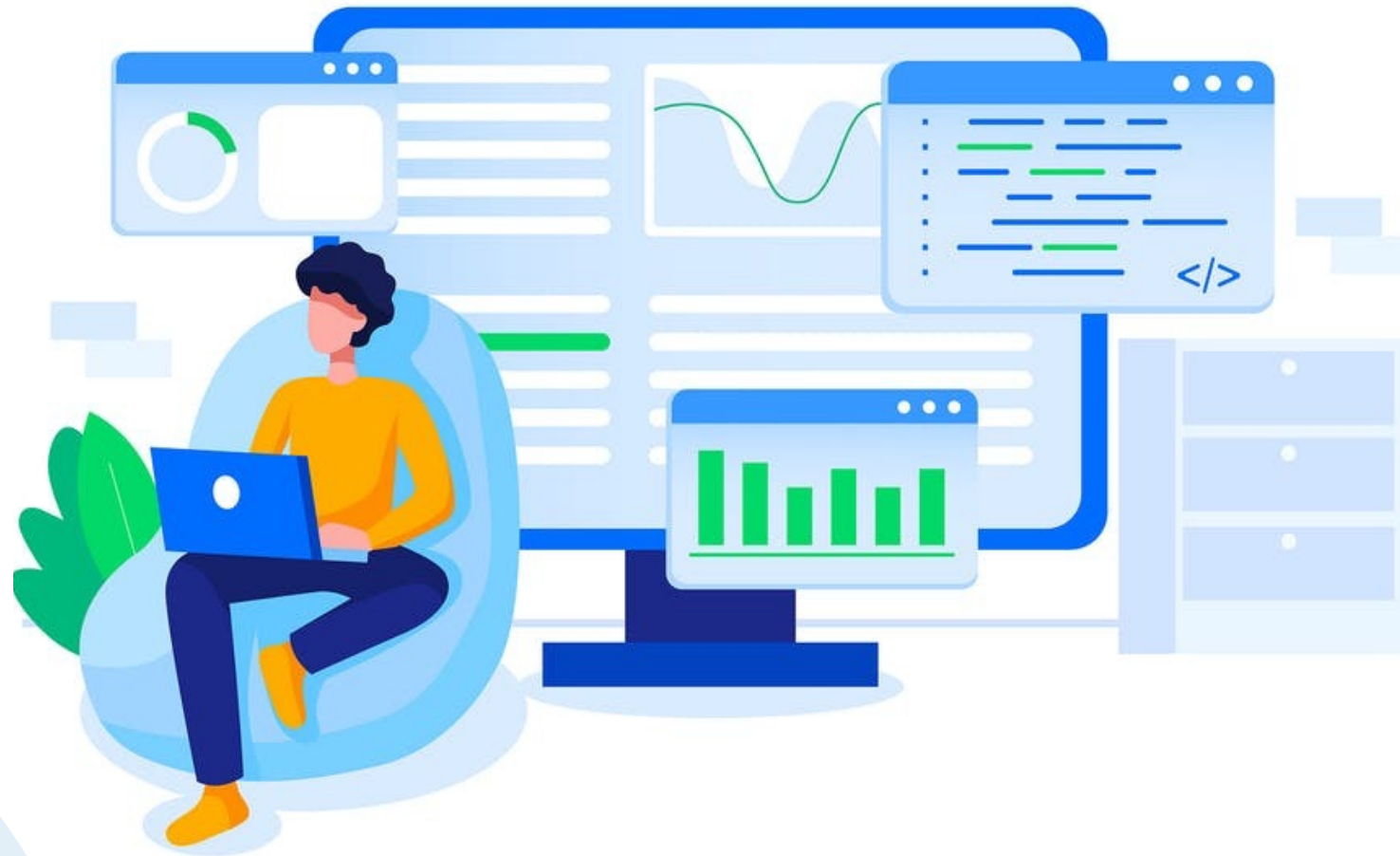

Trend of Cancellation and Revocation of GST Registration



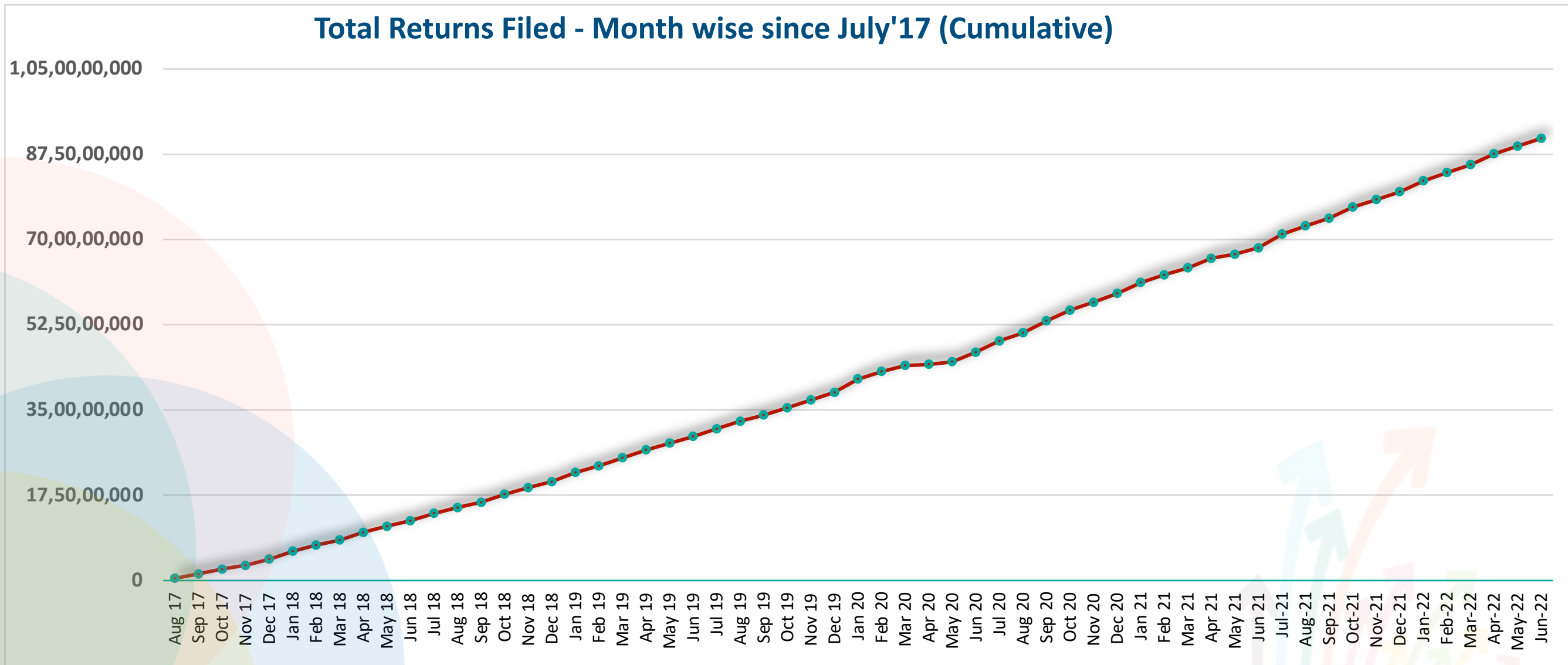

Total Returns Filed (Since July'17)

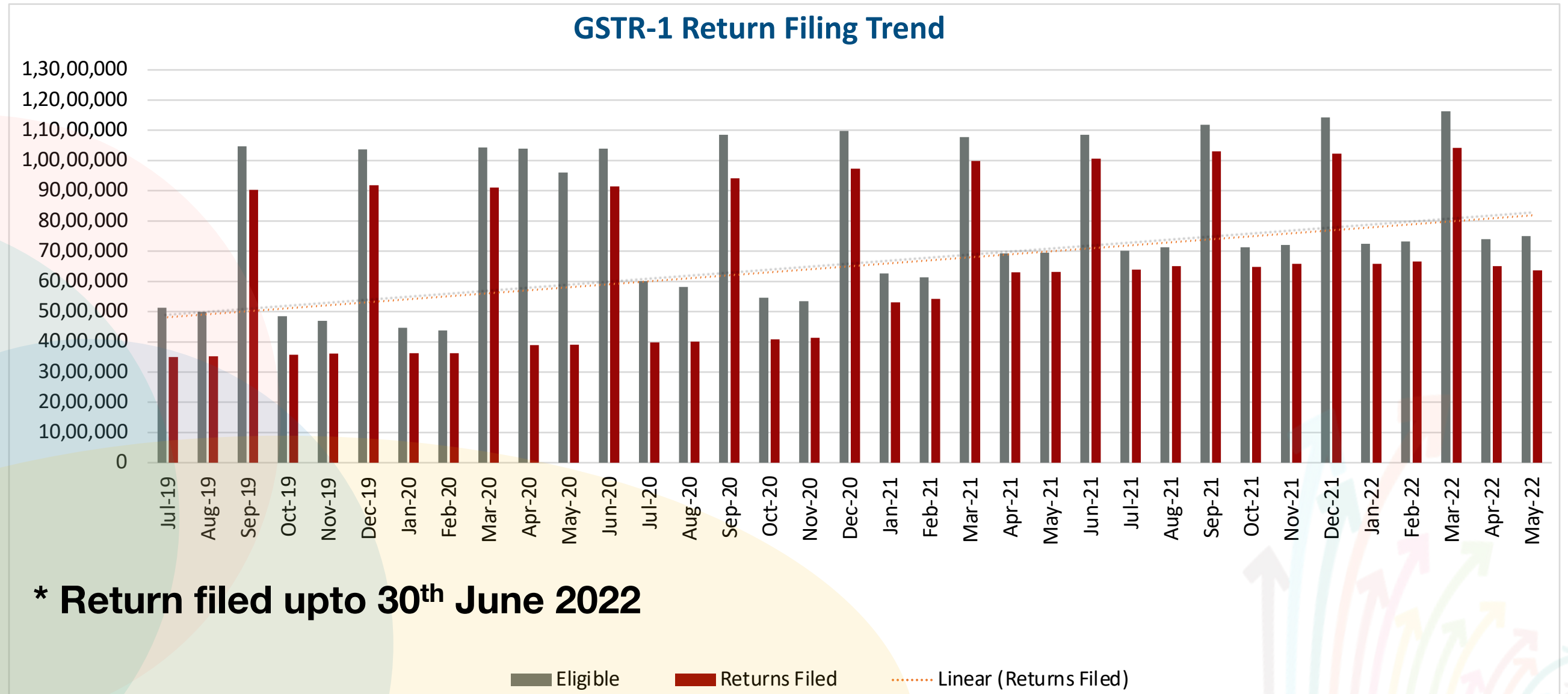
Total Returns Filed - Month wise since July'17 (Cumulative)

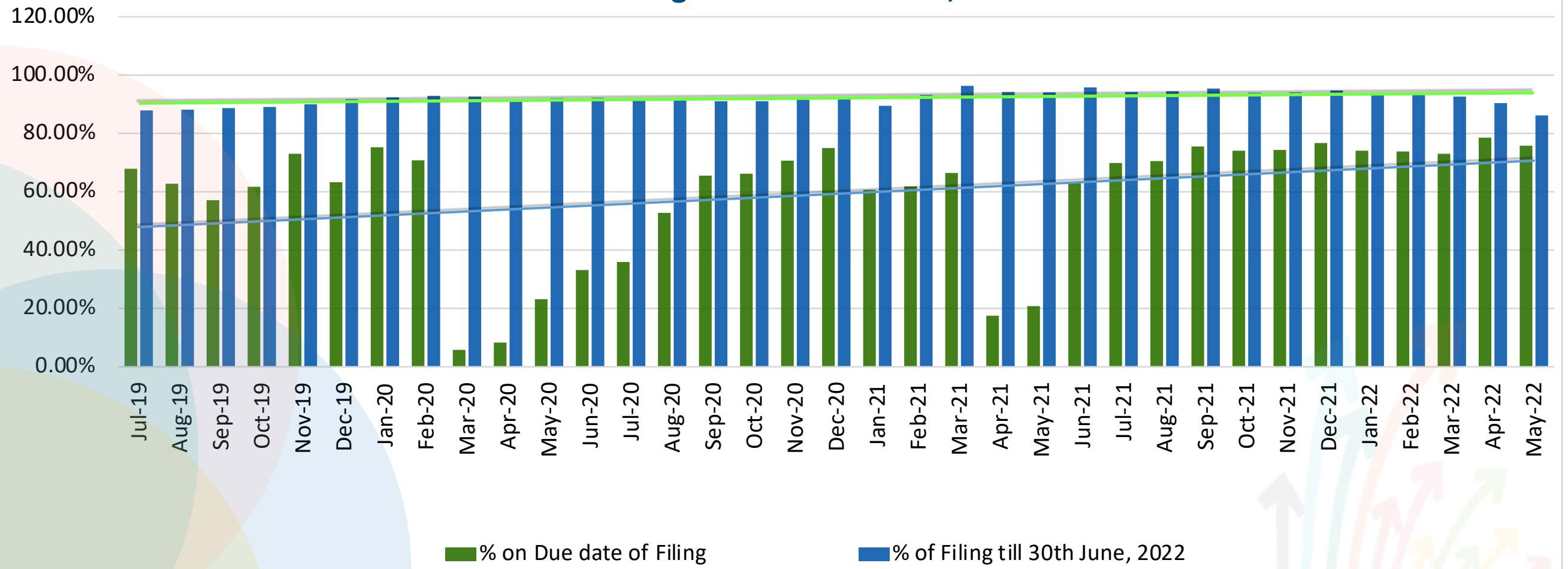

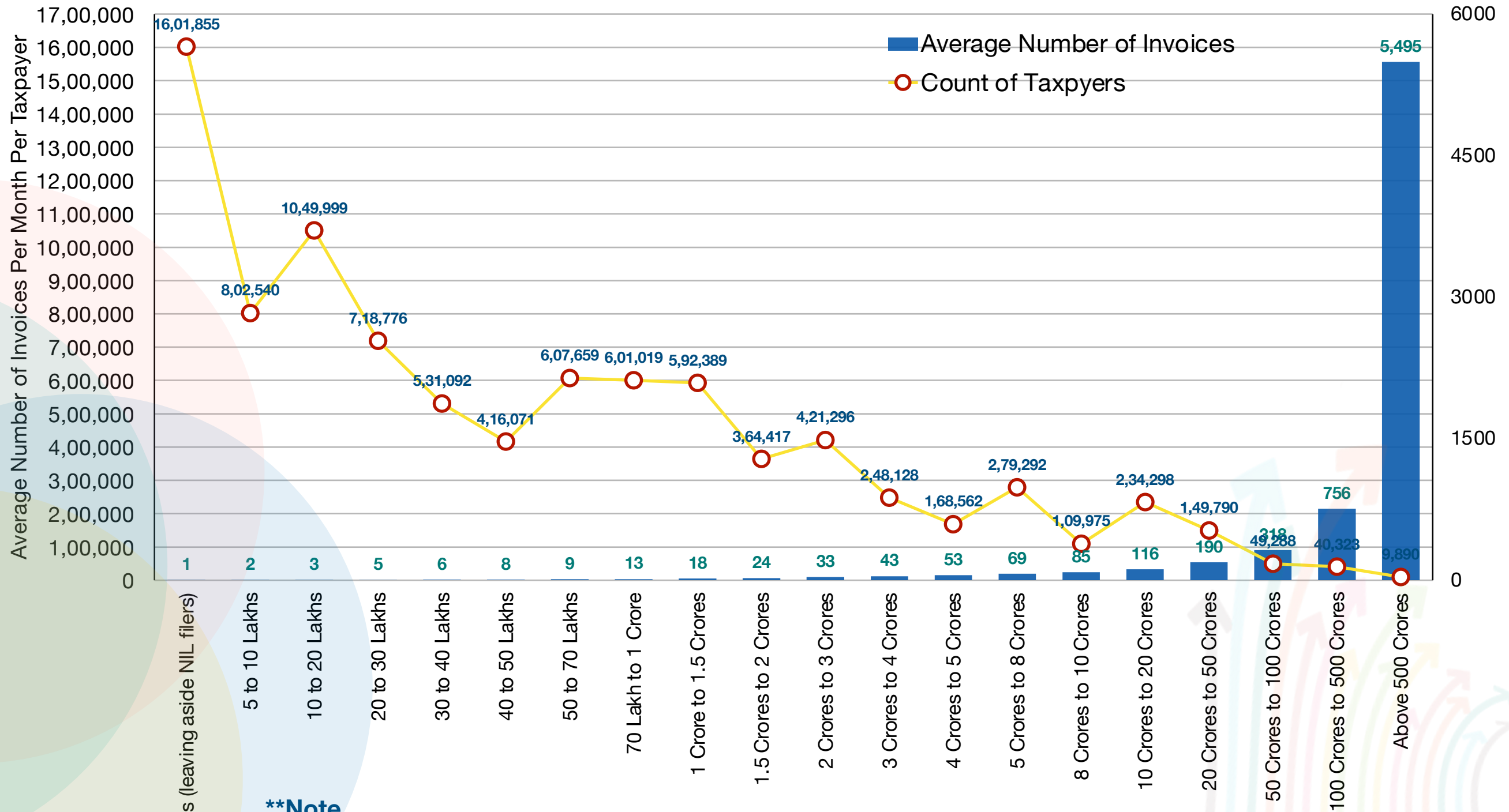

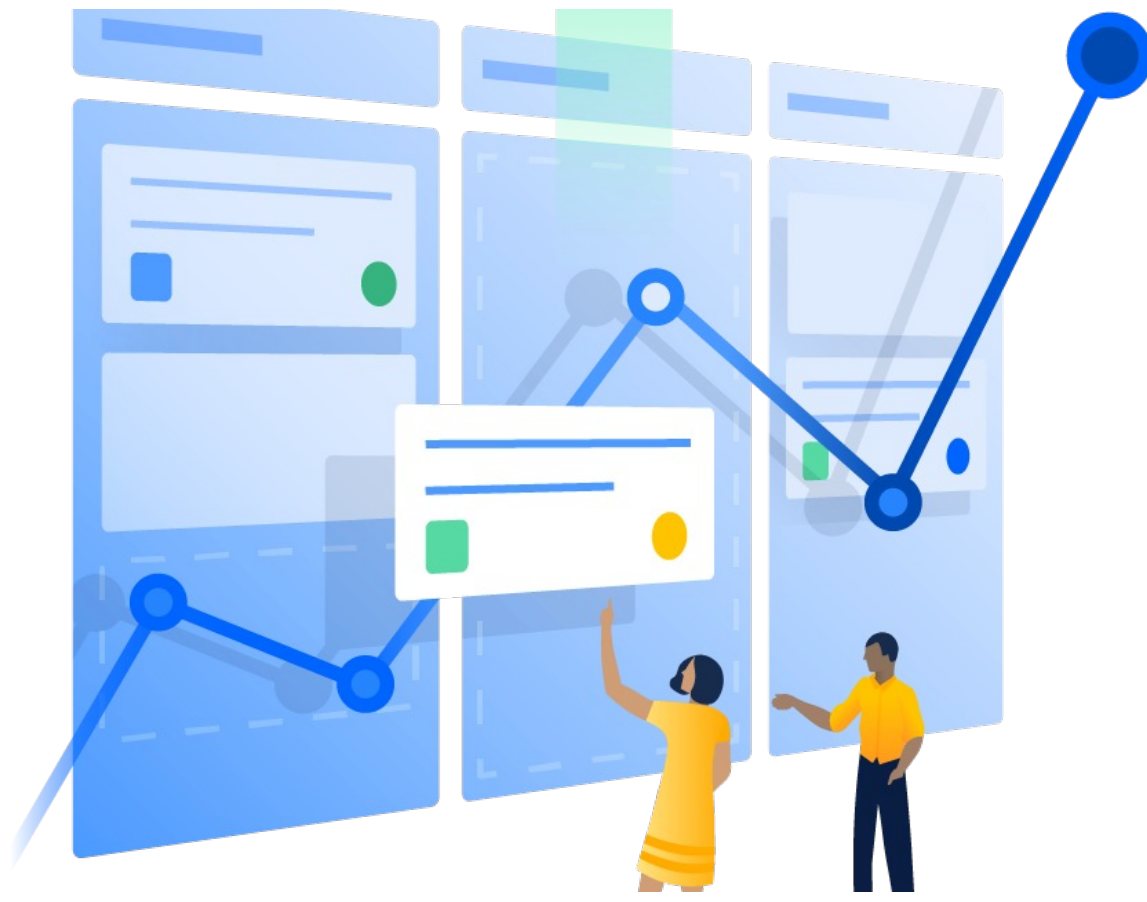

Invoice Count as per Turnover Slabs (at GSTIN Level)

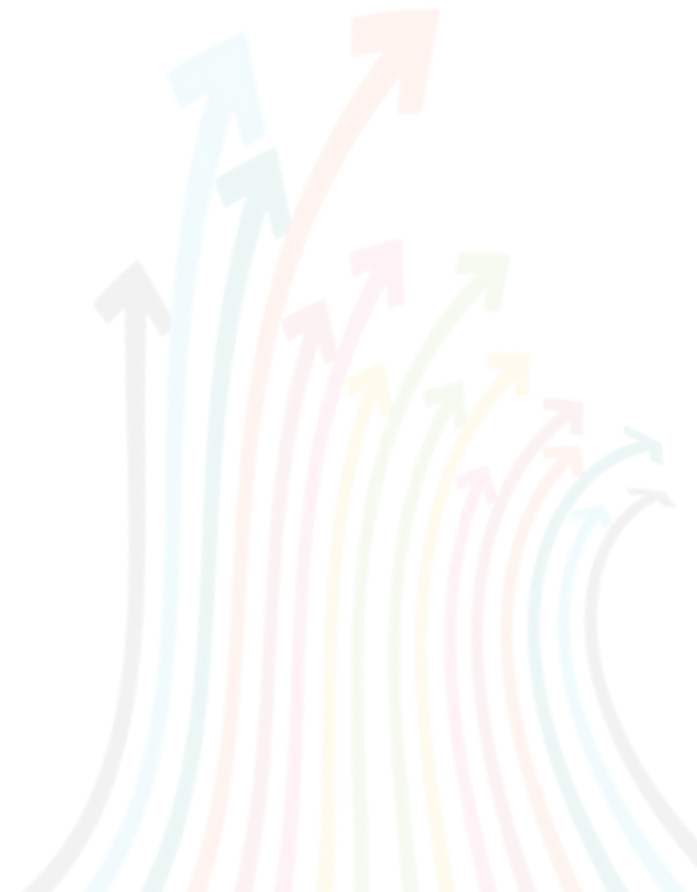

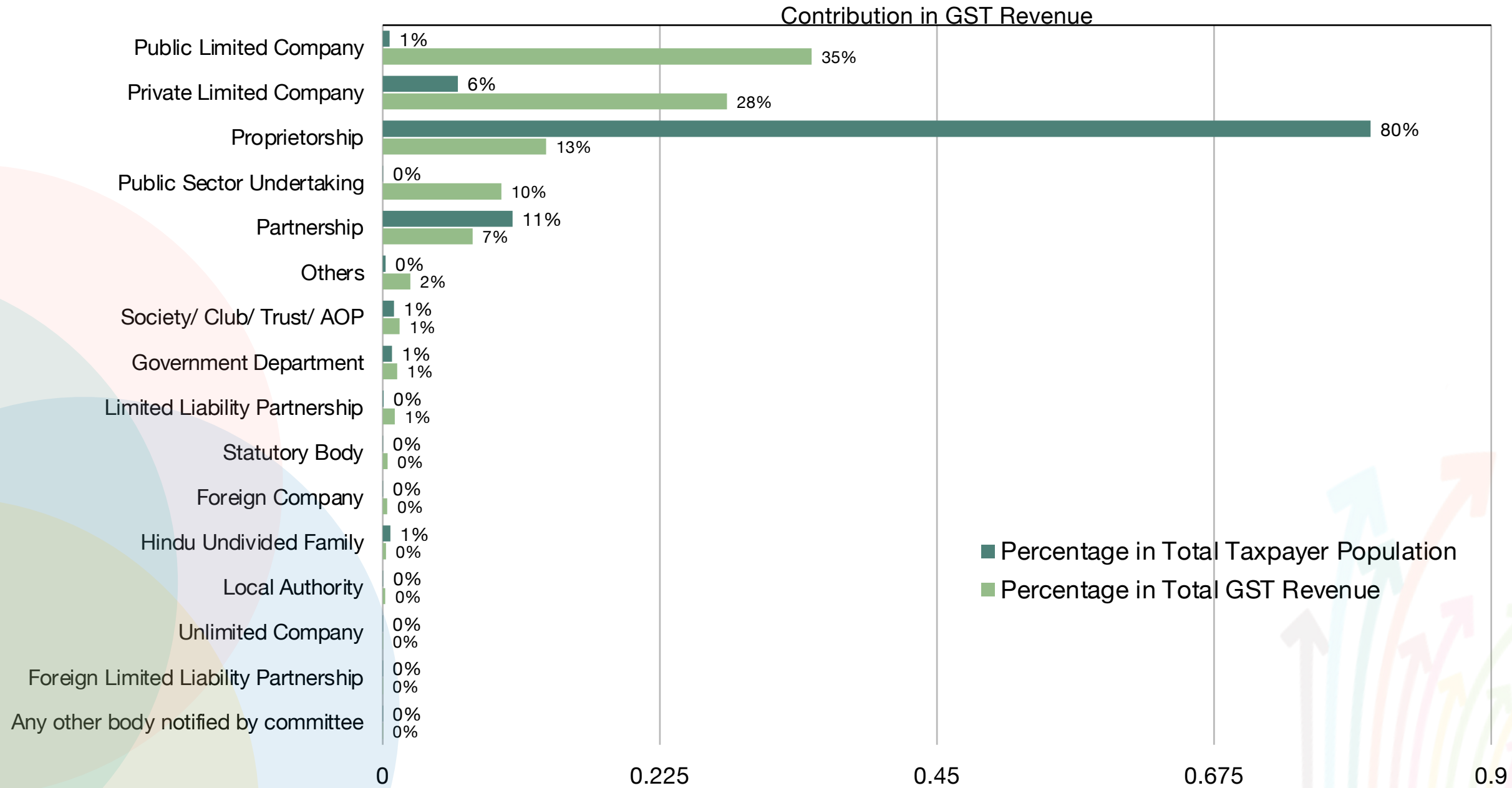

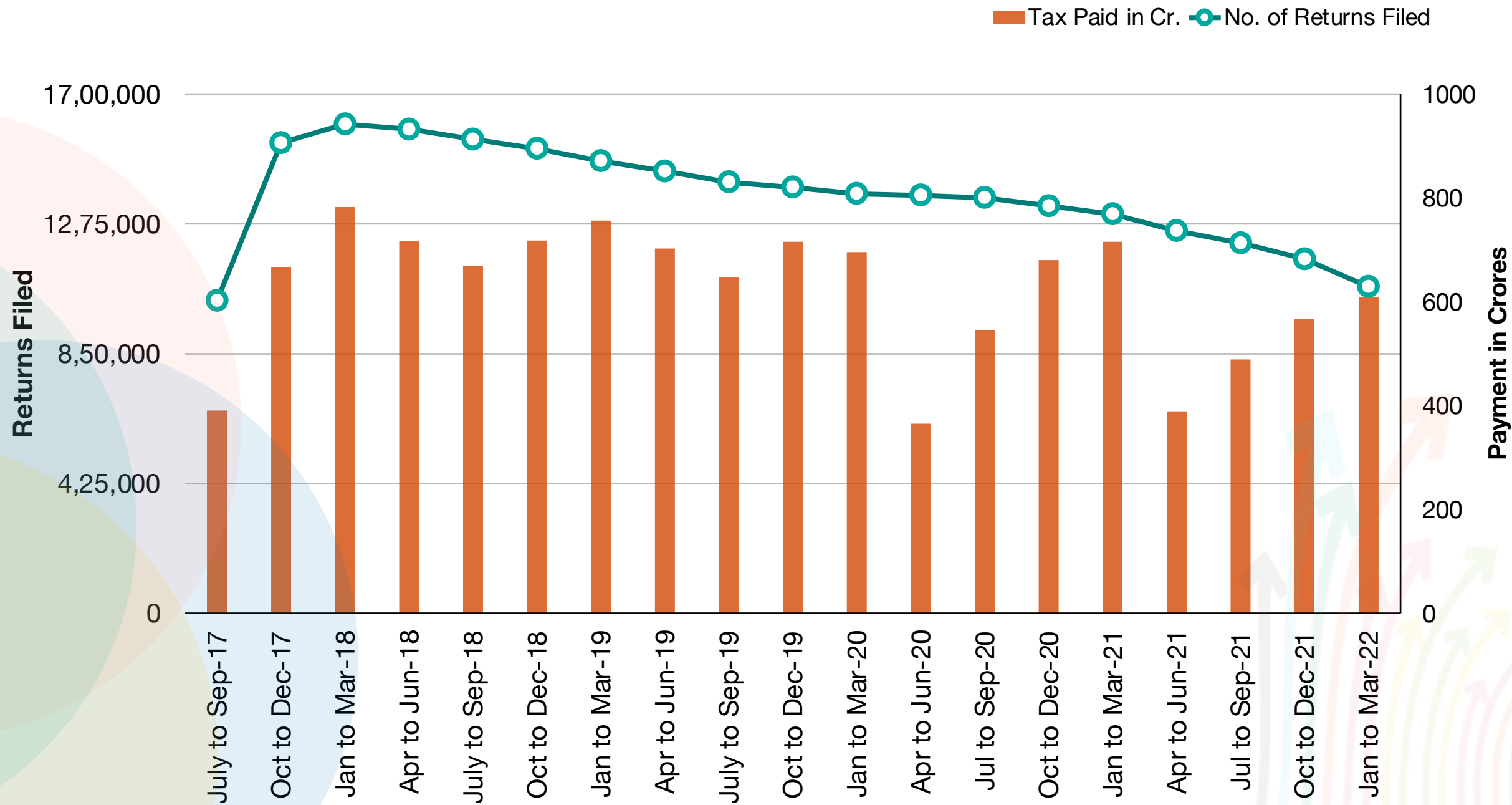

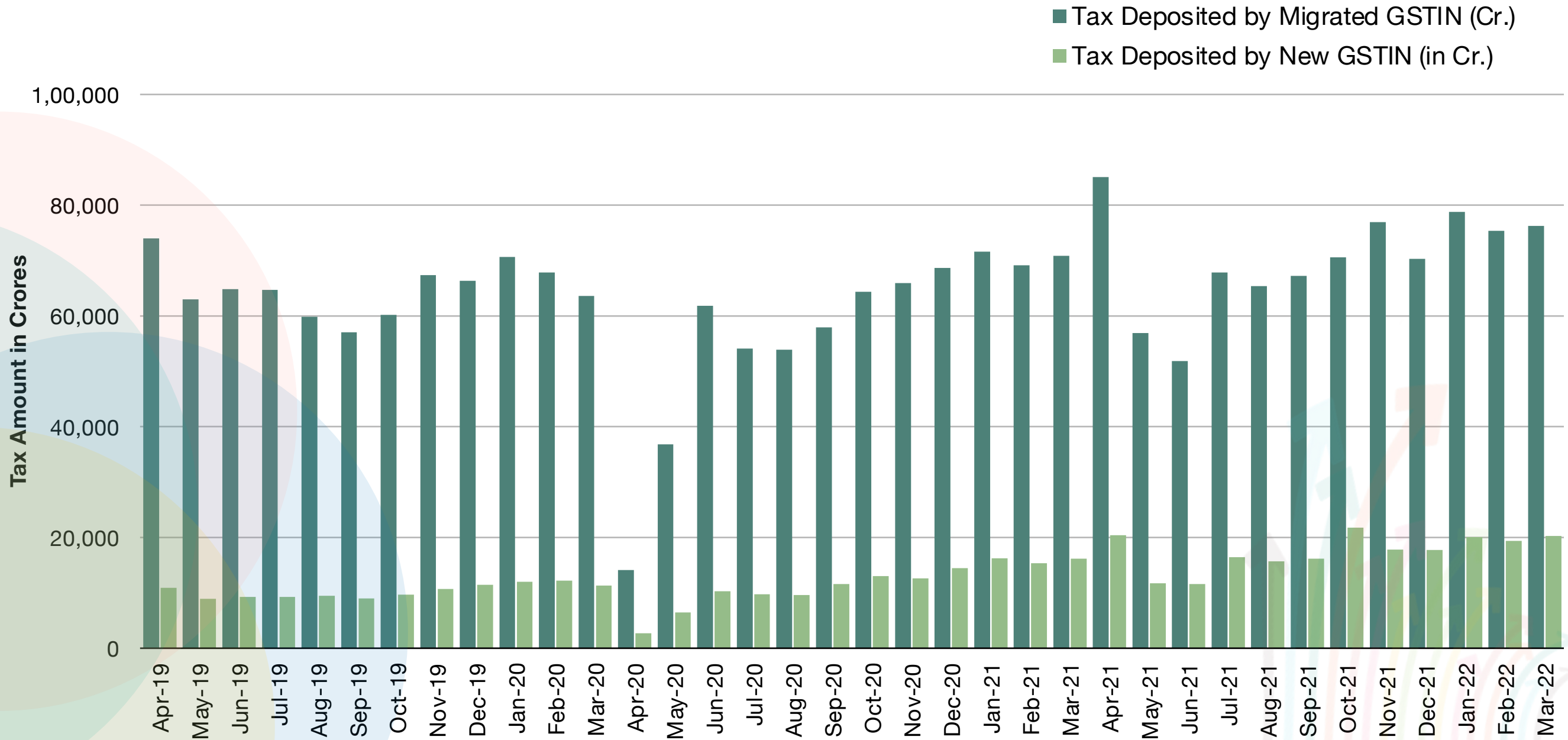

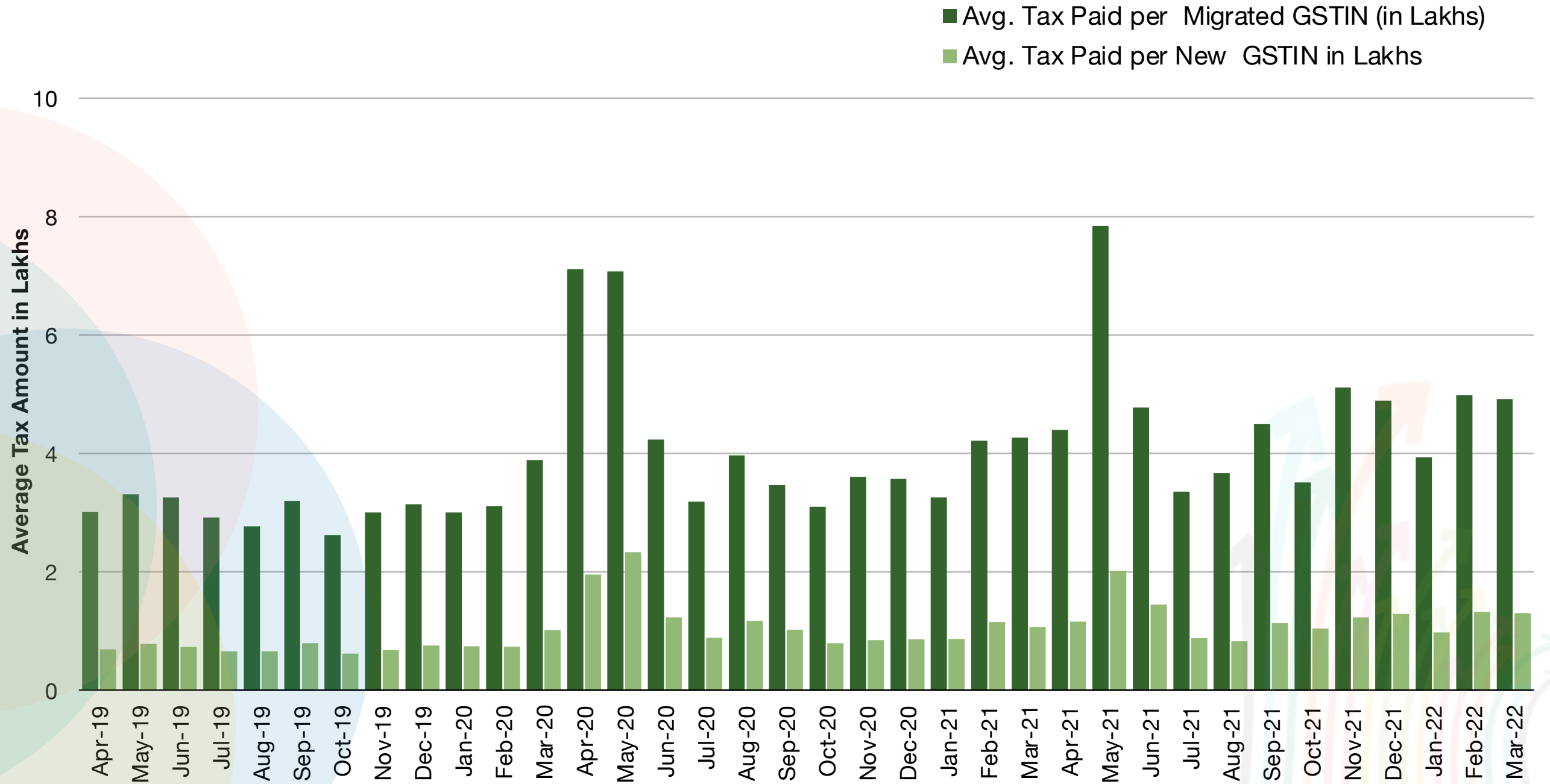
Month wise Tax Collection Trend*

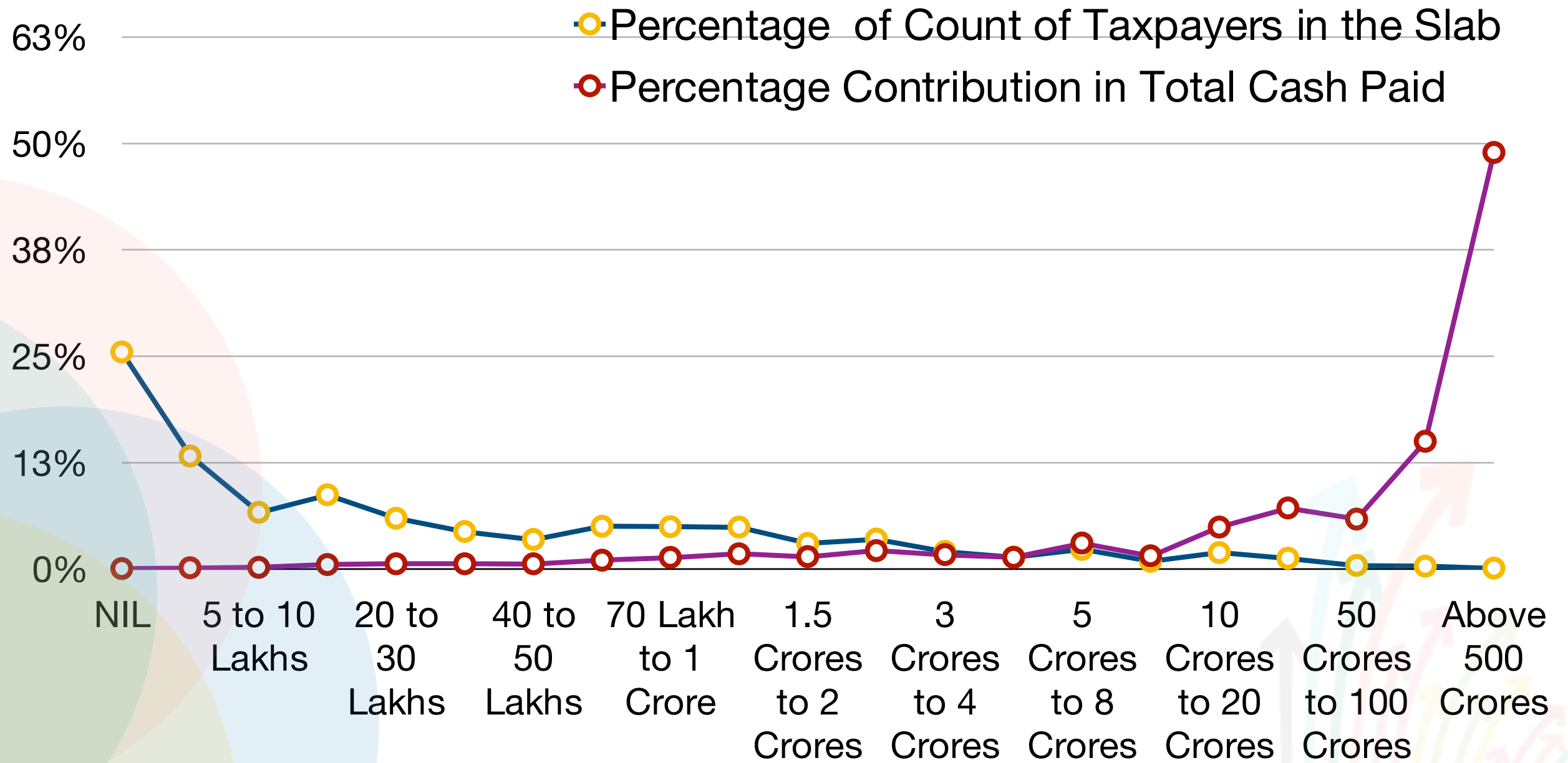

Turnover Slabs and Cash Payment Trends



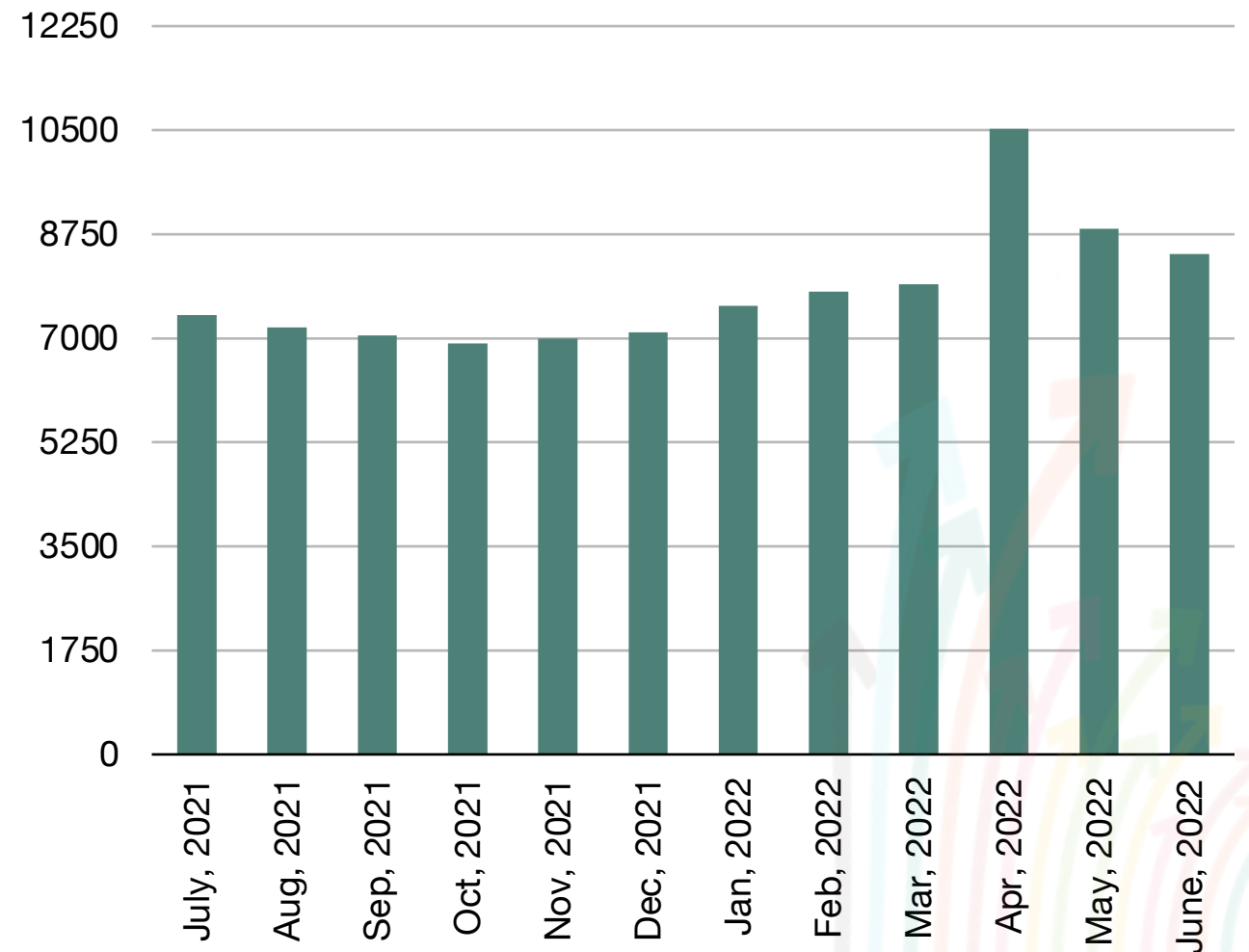

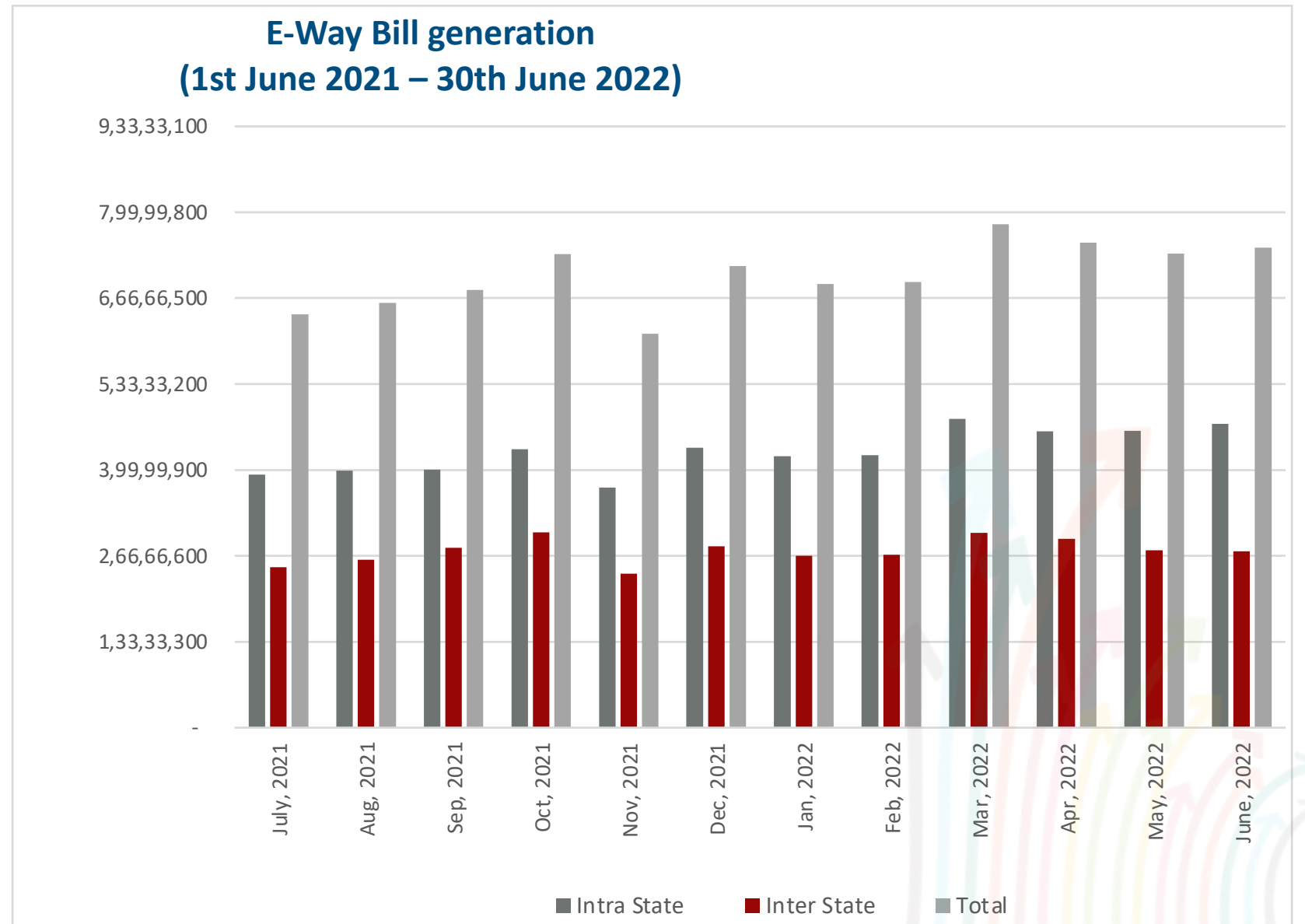

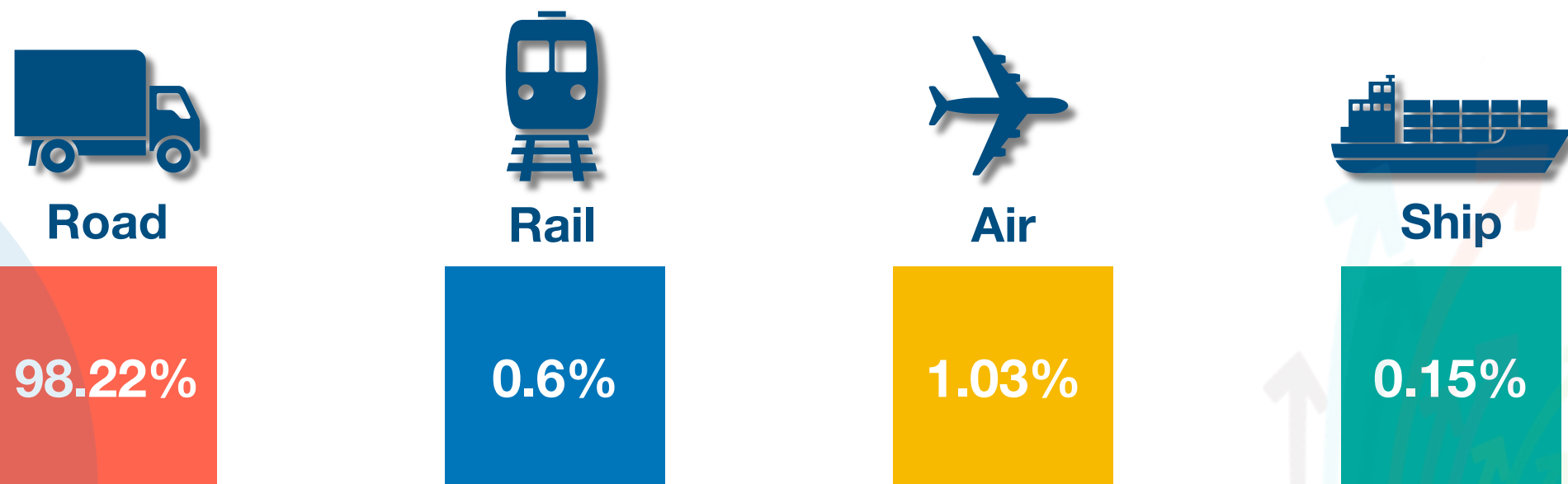

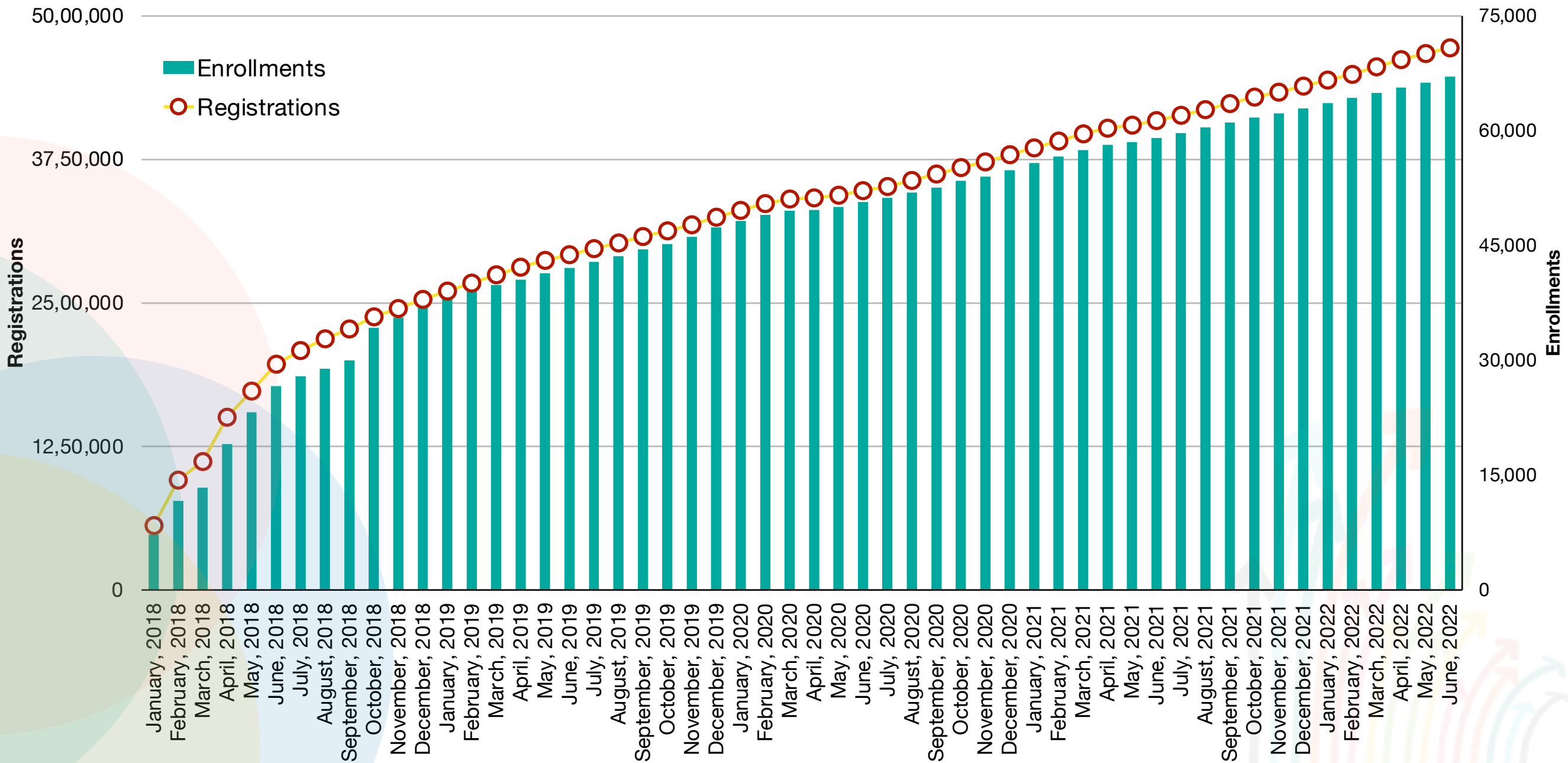

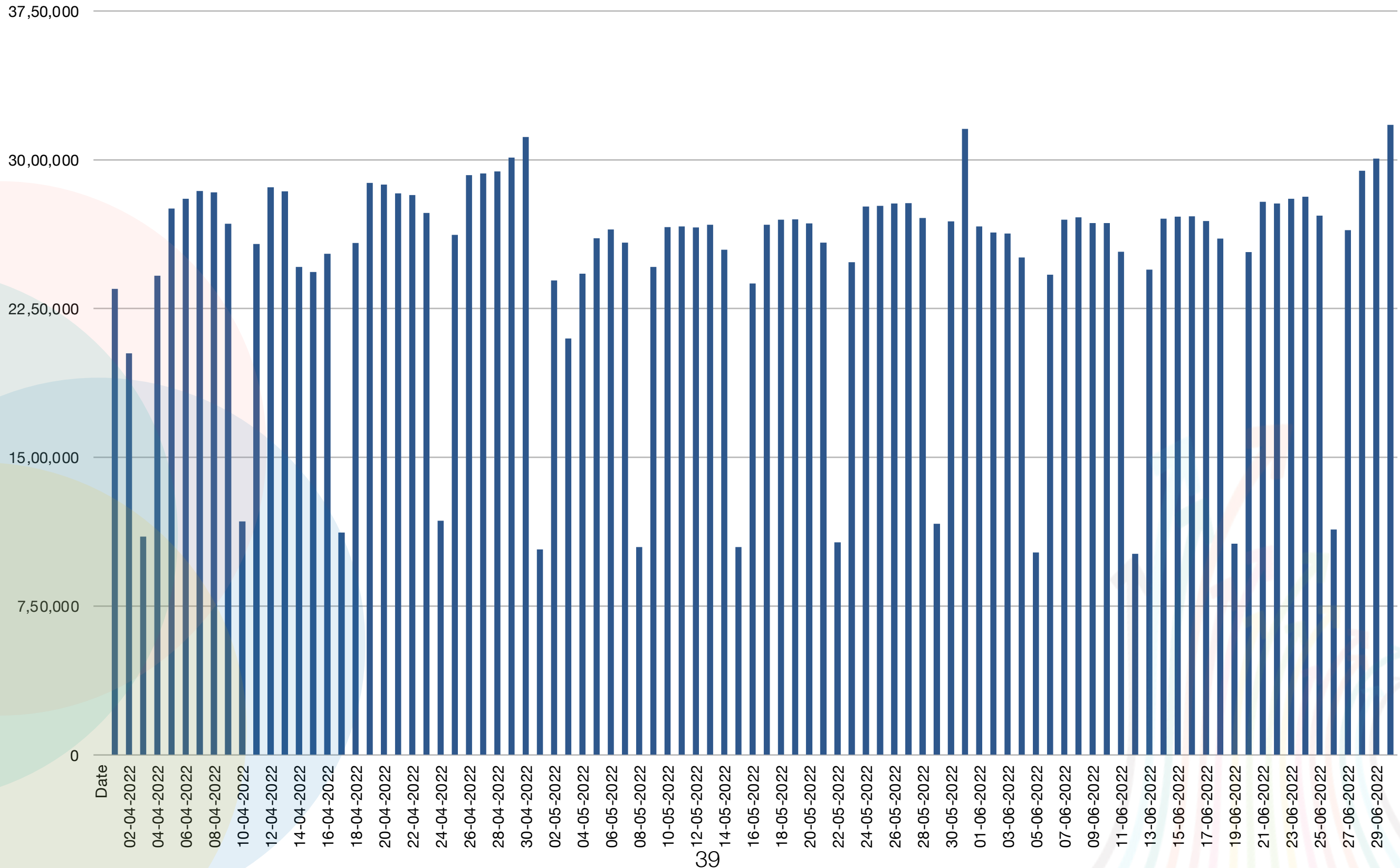
Cumulative Trend of Users' Registration on E-Way Bill Portal (GSTIN holder, Transporters and Unregistered Persons)

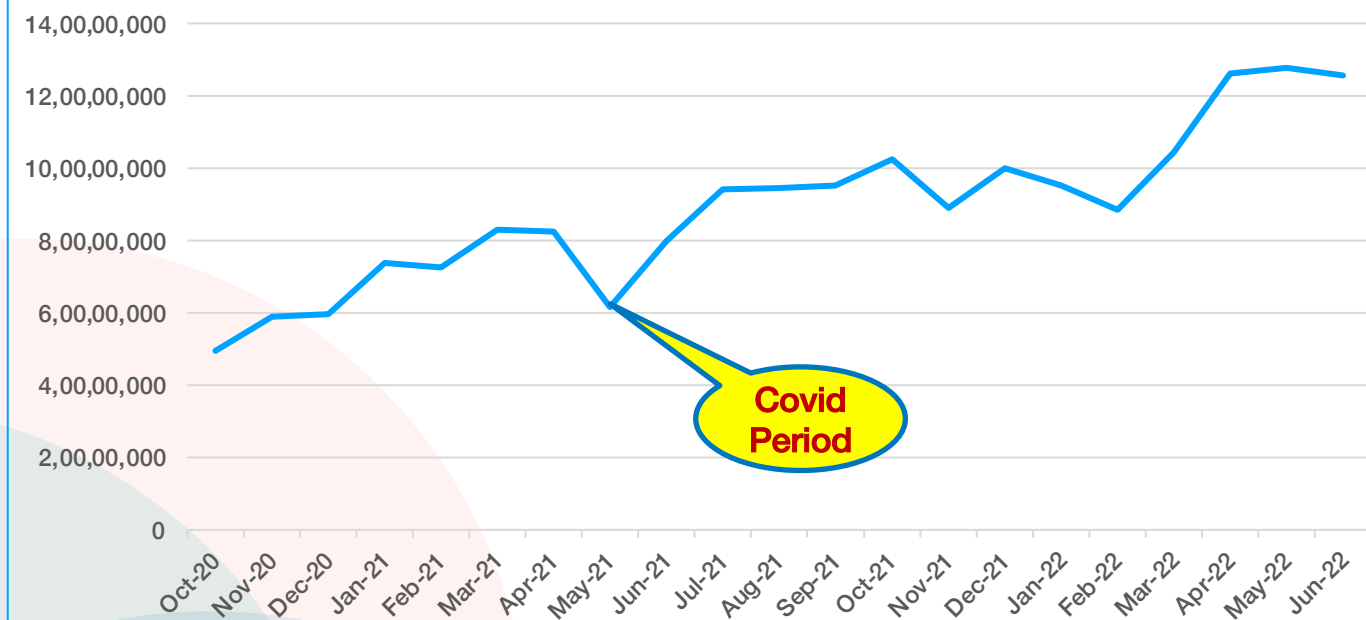

Trend of E-way Bill Generation (1st April 2022 - 30th June 2022)

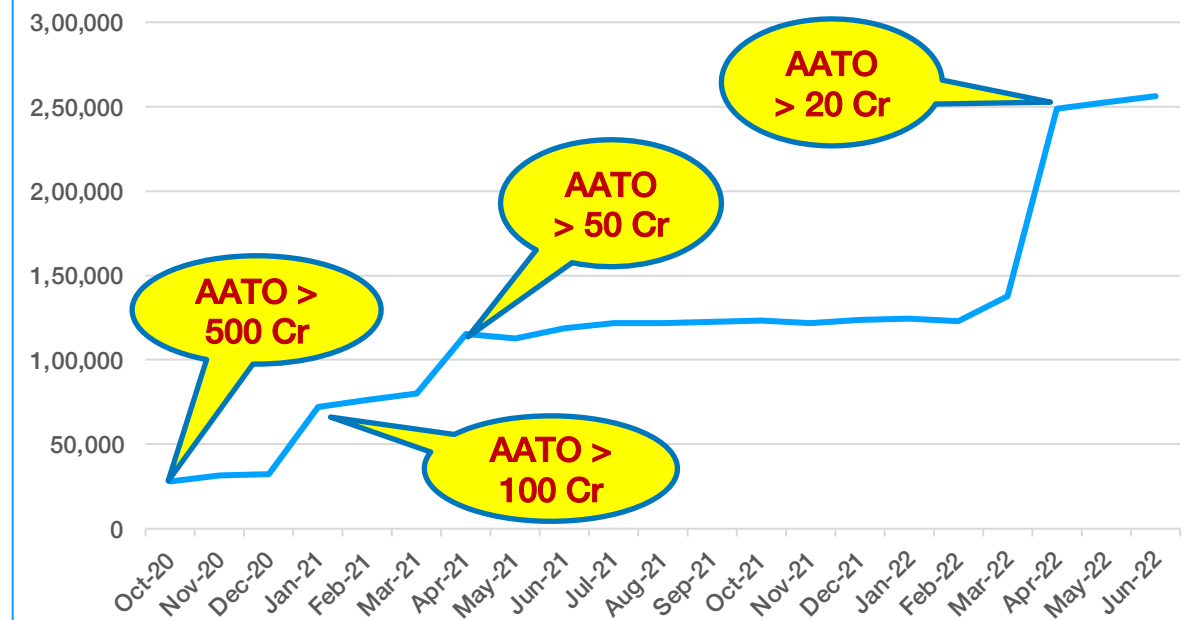


Trend of E-Invoice Generation

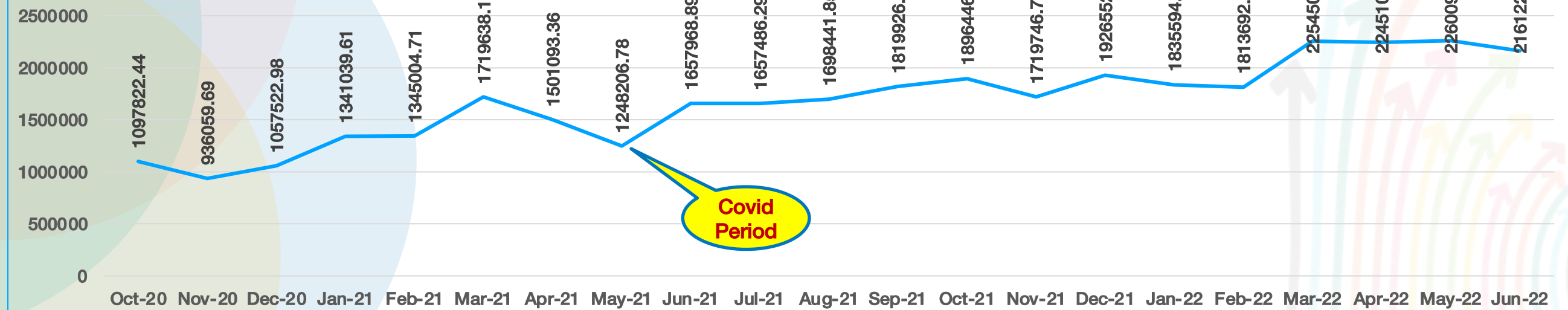
No. of IRN generated
