General Conditions of Application and Issue of Pass

1. Application Form issued free of cost by BETL shall only be used for applying.
2. BETL shall have the right to change/alter/modify the Form of Application as it deems fit.
3. Completed application shall be accepted only with self certified copies of the following documents.
 - a. Valid Vehicle Registration Certificate.
 - b. Photo ID proof- preferably Driving Licence/PAN Card/ID issued by current Employer.
 - c. Address proof- Water/Electricity Bill or Phone Bill/Bank Pass Book/Rent or Lease Agreement/Khata/Sale Deed/Current Employers letter.
3. Application should preferably be handed over to the designated BETL official in person. Application may be submitted through a representative authorised by the registered owner of the vehicle.
4. BETL Operations staff shall be permitted to physically verify the vehicle with the vehicle registration certificate.
5. BETL shall be free to store the application in electronic form.
6. Applicant shall provide factually correct information and agrees that, issue of pass is on the basis of information provided. If BETL discovers information to be factually incorrect/inaccurate, BETL may BLOCK the pass and reserves the right to decline renewal.
7. The pass issued by BETL is NOT proof of ownership of the vehicle or Address or ID.
8. The Applicant agrees that BETL shall be free to modify the configuration of the lanes at the plazas and the process of passage as it deems fit and issue of pass does not constitute any right of passage through any particular lane at any of the plazas.
9. The Applicant agrees to return the OBU in serviceable condition. The Applicant agrees for BETL to test whether the returned OBU is serviceable or not.
10. The Applicant agrees to recharge the OBU at applicable user fee rate notified by BETL, at the POS in the Main/Secondary Base Camp.

Terms and Conditions of Issue and Usage of vehicle On Board Unit (OBU)/Smart Card (SC) based pass.

1. Pass is issued for the particular Registered Number of a vehicle (registered vehicle) and is usable only by that vehicle. Pass is NOT transferable to any other vehicle.
2. Use of pass by a vehicle other than the registered vehicle shall result in charging of full single trip User Fee for that vehicle. BETL reserves the right to BLOCK such un authorised use. BETL reserves the right to decline request for renewal of such pass.
3. The pass will be based on the OBU in the case of cars, LCV/Mini Bus for use of "Elevated Section" or "At Grade Section".
4. A non interest bearing Security Deposit of Rs 1,000 per OBU and Rs 100 per SC shall be payable at time of issue; in addition applicable pass user fee shall be payable.
5. The pass of two wheelers will be based on the SC only for Elevated Section.
6. Valid pass of Elevated Section shall be usable in designated lane only in any of the Elevated Section plazas.
7. Valid pass of At Grade Section shall be usable only in designated lane of Attibele Plaza.
8. SC/OBU is the property of BETL issued to the registered vehicle for bonafide use during the validity of the pass.
9. On expiry of the pass/cessation of usage, the SC/OBU shall be returned to the POS in serviceable condition.
10. On receipt of serviceable SC/OBU, the non-interest bearing Security Deposit shall be refunded by Account Payee cheque in favour of the applicant sent by courier to the registered postal address of the applicant.
11. If the SC/OBU is not reusable by BETL due to any damage, but not if the battery (OBU) is discharged, the Security Deposit shall be forfeited.
12. Expired/discharged battery of OBU shall be replaced at applicant's cost during currency of the pass at the Camp.
13. OBU shall be firmly fixed at right top inner surface of the registered vehicle wind shield at all times.
14. Pass is valid for 30/60/90 days after payment has been received in cash/by credit/debit card as the case may be.
15. Intermittent pass is for specified number of single trips. Each trip will be debited as a single trip.
16. Intermittent trip pass is valid until there is trip balance at the applicable user fee rate. In the event of increase in user fee, the un-used trips in balance will lapse and no refund is admissible for un used trips.
17. In the event of theft/loss/misplacement of OBU/SC pass, the Applicant should forthwith notify BETL by e mail/letter, giving registered vehicle number. On the basis of information furnished, the pass shall be BLOCKED. Subsequently if the Applicant recovers the pass, on his request, by e mail/letter the pass will be UNBLOCKED.
18. Pass value paid is NOT refundable on any grounds.
19. For any printed account statement, a stationary of Rs 10/statement/30 day statement will be charged.
